

Lifetime Limited Warranty

PROVIDED BY Platinum Metals



PLATINUM METALS LLC extends the following limited paint warranty to XX ("ZZ") on its Metal Roofing Systems for use in coating coils of metal which will be fabricated by ZZ into commercial, industrial and residential building construction products installed in the United States and Canada. This is not a corrosion warranty.

Section A | Limited Lifetime Warranty

PLATINUM METALS LLC warrants that its Metal Roofing Systems will conform to the performance standards listed below (the "Limited Lifetime Warranty"):

1. Within 40 years from the date of installation, the Metal Roofing Systems will not peel, flake or otherwise lose adhesion to an extent that is apparent in ordinary outdoor visual observation. NOTE: Slight crazing or cracking may occur on roll-formed edges or break bends at the time of forming, and is considered standard – such crazing or cracking shall not constitute a basis for complaint under this Limited Lifetime Warranty. *Further, failure due to substrate issues including, but not limited to corrosion, is not covered by this Limited Lifetime Warranty. Various metals may react differently under different atmospheric conditions.*
2. Within 40 years from the date of installation:
 - A. Vertical panels of the Metal Roofing System will not change color more than five (5) Delta E. (Hunter units) and non-vertical panels will not change more than seven (7) Delta E. (Hunter units) when measured per ASTM D 2244 on clean surfaces after removing dirt, other surface deposits and chalk per ASTM D 3964. It is understood that color change may not be uniform if the surfaces are not equally exposed to solar radiation and other elements; and
 - B. Vertical panels of the Metal Roofing System will not chalk more than a number eight (8) rating and non-vertical panels will not chalk more than a number six (6) rating when measured per ASTM D 4214, Method A.

Certain bright, saturated, non-standard colors are not attainable without using formulations that are more susceptible to the effects of outdoor weathering, and as such will carry reduced warranty coverage. PLATINUM METALS LLC will inform you in writing at the time of color matching if the color is subject to reduced warranty coverage.

This Limited Lifetime Warranty does not apply to other causes of degradation, including:

1. Failure to fabricate the pre-painted coil coated with Metal Roofing System within 6 months after coating can effect fabrication properties that may void the warranty.
2. Failures or damage resulting from under-film or edge corrosion, or failure or defects of the metal substrate;
3. Acts of God, falling objects, explosions, fire, external forces or other circumstances beyond our control;
4. Metal Roofing Systems which is applied to other than first quality aluminum, Galfan®, Galvalume® steel, or galvanized steel;
5. Metal Roofing Systems which is not applied in accordance with good practice in the coil coating industry, including proper cleaning and pretreatment of the substrate;
6. Mishandling of any substrate coated with the Metal Roofing System, including abuse, modification, improper fabrication ,storage or use;
7. Failure to properly clean and remove organic debris including, but not limited to, tree leaves, tree limbs, pine needles, dirt, fungus, moss;
8. Metal Roofing Systems that have been stored/installed in such a way that allows contact with animals or animal waste;
9. Harmful fumes or foreign substances in the atmosphere, or salt spray;
10. Metal Roofing Systems which have been damaged due to moisture entrapment in coils and/or bundles during transit or storage or which has been stored or installed in such a way that allows standing water on the coating;
11. Significant differences in insulation below coated metal panel;
12. Where materials / items are attached / adhered to the product.

Section B

1. Platinum Metals warrants that the color-coated finish applied to its steel roofing and siding panels will not crack, peel or lose adhesion. This does NOT include minute fracturing, which may occur in proper fabrication of the building parts. Failure due to substrate corrosion is excluded. This warranty does not apply to the reverse side finish of the products.
2. Platinum Metals also warrants that the color-coated finish applied to its steel roofing and side panels will not, within a period of thirty years after installation or a period of thirty years and one month after the date of shipment (whichever comes first), chalk or lose color according to the following grids. Additionally, chalk ratings are measured in accordance with the standard procedures specified in ASTM-D-2244-02. Color change shall be measured on an exposed painted surface that has been cleaned of surface soils and chalk, and the corresponding values measured on the original or unexposed painted surface. It is understood that fading or color changes may not be uniform if the surfaces are not equally exposed to the sun and elements.

Sidewall: Color 5 | Chalk 8

Roof: Color 7 | Chalk 6

3. **DISCLAIMER OF WARRANTY:** THE EXPRESS WARRANTY STATED HEREIN IS THE EXCLUSIVE WARRANTY APPLICABLE TO PLATINUM METALS PRIME PAINTED MATERIAL ONLY, ROOFING AND SIDING PANELS. PLATINUM METALS MAKES NO WARRANTIES OR GUARANTEES, EITHER EXPRESSED OR IMPLIED, BEYOND THE FACE HEREOF INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. PLATINUM METALS SHALL HAVE NO OTHER LIABILITY WITH RESPECT THERETO. This warranty will apply to those panels refinished or replaced but only for the period of time left on the original warranty. No employee or representative of Platinum Metals is authorized to change this limited warranty in any way or grant any other warranty regarding the product.
4. **LIMITATION OF LIABILITY:** THE EXCLUSIVE REMEDY FOR ANY AND ALL CLAIMS ARISING FROM THIS LIMITED TO PLATINUM METALS OR REPLACING DEFECTIVE PANELS FOR REFUNDING THE PURCHASE PRICE OF SUCH PANELS AS PLATINUM METALS SHALL ELECT. PLATINUM METALS SHALL NOT BE LIABLE FOR ANY LOSSES, DAMAGES, OR EXPENSES, WHETHER DIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES. PLATINUM METALS' TOTAL LIABILITY IS EXPRESSLY LIMITED TO THE PURCHASE PRICE OF THE PLATINUM METALS STEEL ROOFING AND SIDING PANELS.
5. Claims under this warranty must be made in writing to Platinum Metals at the address set forth below within 30 days after the discovery of the defect. The notice to Platinum Metals shall include adequate identification of the material involved, nature of the claimed defect, date of installation, date of shipment and order number. Failure of the claimant to provide such information in the time provided shall be deemed as a waiver of the claimant's right herein. Platinum Metals shall have an additional 30 days to inspect the Platinum Metals steel roofing and siding panels before an further action shall be taken.
6. Platinum Metals does not warrant or guarantee the interior or reversed side finish or prepainted materials used for interior application.
7. Platinum Metals does not warrant or guarantee claims arising from damage to panels due to exposure to salt, salt water, water spray, corrosive or harmful chemicals (whether solids, liquids, or gases), airborne contaminants, hail or other agents of a similar nature.
8. Platinum Metals does not warrant or guarantee claims arising from the following:
 - A. Damage or defects caused by acts of God, falling objects, external forces, explosions, fire, riots, civil commotion, acts of war, excessive radiation, or other similar or dissimilar occurrences beyond Platinum Metals' control.
 - B. Minor hairline cracking of the paint finish.
 - C. Defects or damages to the painted steel roofing and siding panels caused by handling, shipping, transit, processing, storage or installation; damage due to failure of the substrate.
 - D. Damage caused by moisture or other contamination prior to installation.
 - E. Steel shavings or minute iron particles from sawing sparks that come in contact with the painted surface.
 - F. Non-vertical panels that don't have an adequate degree of pitch so as not to allow any free standing or accumulation of standing water.

- H. Deterioration to the panels caused directly or indirectly by panel contact with fasteners. The selection of suitable fasteners rests solely with the buyer.
- I. Weather uniformity under non-uniform conditions.
- J. Unusual harmful fumes, chemically aggressive environment, foreign substances in the atmosphere, standing water or direct salt spray.
- K. Damage due to green, wet, or treated lumber.

9. Platinum Metals extends this warranty solely to the buyer. This warranty is not transferable and non-assignable. Further, it is applicable only to the original owner of any structure where the material is installed. The warranty contained in paragraph 1) is limited to 40 years.
